## LATE FEES (PENALTIES)

If payment is not received by the close of business on the date due a penalty of 10% will be added to the amount due. If payment is not received by the close of business on the 15th day after the due date an additional penalty of 25% will be added for a total of 35%. In accordance with LVMC 6.40.130(C), all fees and penalties not received within 60 days after the date due will result in the license being automatically revoked.

## OUT-OF-BUSINESS

You must formally notify Business Licensing if your business has CLOSED or you will continue to be subject to fees, penalties, and collections. All unpaid balances must be paid prior to closing. ## CONVENTION LATE PAYMENT PENALTIES

Fees are due and must be received before the close of business on the 15th day after the due date shown. If fees are not paid by the due date, a penalty of 10% shall be added, plus an interest in the amount of 1.5% per month or fraction thereof from the date the tax became due.

A	Slot machines if 12 or less in one location, each machines .....	\$ .50
B	Slot machines more than 12 in one location, each machine .....	1.50
C	Casinos having less than two games, per game .....	6.00
D	Casinos having 2 to 5-1/2 games, per game.....	15.00
E	Casinos having 6 or more games, per game.....	24.00

*In determining the number of games, craps, roulette, blackjack, bingo games, race & sports books and wire betting services, each shall be considered a full game. All other games shall be considered one-half game and charged at one-half of the game charge.*
