PROFESSIONAL BUSINESSES

If you are a professional business you are required to declare the number of professionals working in your firm or business at the time of billing. A professional is defined as any person who holds a license, certificate, registration, permit or similar type of authorization issued by a state regulatory body as defined in NRS 622.060, or who is regulated pursuant to Nevada Supreme Court Rules, AND practices his or her profession for any type of compensation as an employee (for this purpose "employee" includes an owner, sole proprietor, member partner or associate of a professional business).
